Section 3. Hazards Identification	
<b>Potential Acute Health Effects</b>	Very hazardous in case of skin contact (irritant), of eye contact (irritant), of ingestion, of inhalation. Hazardous in case of skin contact (corrosive), of eye contact (corrosive). The amount of tissue damage depends on length of contact. Eye contact can result in corneal damage or blindness. Skin contact can produce inflammation and blistering. Inhalation of dust will produce irritation to gastro-intestinal or respiratory tract, characterized by burning, sneezing and coughing. When applied in the vagina of pregnant rats at much higher doses than those used in spermicides, it caused increased resorptions leading to fetal death, and reduced litter size and weight. No adverse reproductive effects have been reported after oral treatment of rats and guinea pigs and dermal administration to rats.
<b>Special Remarks on other Toxic Effects on Humans</b>	Acute Potential Health Effects: Skin: Causes severe skin irritation and burns. Eyes: Causes severe eye irritation and burns. Ingestion: Harmful if swallowed. May cause severe and permanent damage to the digestive tract. Causes gastrointestinal (digestive) tract burns. May affect behavior (central nervous system depression, depression) and metabolism. May produce burning pains in the mouth, throat, and abdomen, profuse salivation, muscle weakness. 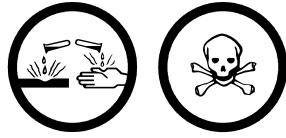
